AGREEMENT FOR ACADEMIC EXCHANGES

BETWEEN

PURBASTHALI COLLEGE

AND

This Agreement is made in Purbasthali College between Purbasthali College (an affiliated college under The University of Burdwan) and Akui Kamalabala Women's College (an affiliated college under Bankura University). Both institutes purport to promote academic collaboration and exchange of knowledge and resources in areas of mutual interest, such as research, faculty and student exchange programs, conducting joint seminars/ conferences/ workshops/ symposia, and other academic activities.

I. THE REPRESENTATIVES

The representatives of each institute shall agree upon specific publicity, recruitment of students, and other collaborative projects involving both institutions. For Purbasthali College, its representative shall be the Head of the Institute; and for Akui Kamalabala Women's College, its representative shall be the Head of the Institute. Collaborative activities may be subject to additional terms and conditions agreed upon in writing by the said representatives.

II. PRINCIPLES OF STUDENT EXCHANGE

Exchange of students shall be reciprocal and balanced over the duration of this agreement and may be determined on a case by case basis. The exchange of students shall be made keeping in mind the rules of UGC, West Bengal state government, and the affiliating university, as the case may be. Exchange students will be accorded the rights and privileges of regular attendance at the host institution, excluding the rights to graduate and /or earn degrees at

III. APPLICATION AND ADMISSION

The Students who are willing to participate in the exchange program are required to formally apply to their respective Head of the institute (or other designated official). It is the duty of the home institute to nominate the students on the basis of a selection criteria determined by them and forward the list with necessary documents to the host institute within the stipulated time, if any. The host institute reserves the right to review the applications of the students/ list of students and make the final decision concerning their admission.

IV. FEES AND SCHOLARSHIPS

Exchange students shall pay tuition fees to their home institute while tuition fees will be waived at the host institution. Neither institute shall charge exchange students for tuition or application fees. Exchange students may apply for available scholarships at the host institute. The host institute may collect certain mandatory fees from incoming students which are not required from outgoing students. All such fees will be specified in advance.

V. REGISTRATION AND RECORDS

All exchange students must be full-time registered student of the home institute. The records of the exchange students will be made considering them as regular students of the host institute. An official transcript of attendance and marks/grades will be sent to the head of the home institute on the completion of the period of exchange. Any academic credit that an exchange student receives from the host institute may be transferred back to the home institute in accordance with procedures determined by the home institute.

VI. STUDENT OBLIGATIONS

Exchange students will be responsible for ensuring their own transportation arranged either individually or by the home institute, and the host institute is neither liable to give travel expenses to them nor responsible for providing financial aid for any purpose to an exchange student. It is the responsibility of the exchange students to secure their own housing accommodations, if required, however, on request of the particular student, the host institute may provide assistance in locating appropriate housing facility. The host institute reserves the right to dismiss/ prohibit any participating student at any time for academic or personal misconduct in violation of established regulations of the host institute. The dismissal of a participant shall not abrogate the agreement for the arrangements regarding other participants. Exchange students are subject to the same rules and regulations as the regular students of the host institute. Upon completion of the exchange period at the host institute, the participating students must return and report to their home institute. No extension of stay will be allowed unless otherwise determined by a mutual consent.

VII. FACULTY EXCHANGE

Both institutes agree to facilitate the exchange of faculty members. This will involve identifying suitable candidates for exchange, coordinating their travel and accommodation, and ensuring that they have a productive and enjoyable experience. The faculty members under this exchange may be invited to deliver lecture/talk, participate in academic events/ programs like seminars/ conferences, workshops, symposia, or contribute to/ collaborate in the teaching-learning process of the host institute. The length of visit/ exchange, topic, course curricula, and compensation will be resolved on a case by case basis.

VIII. ORGANIZING JOINT RESEARCHES, PROJECTS, EVENTS

Both institutes agree to collaborate on research and projects of mutual interest. The institutions will work together to identify research areas of common interest, and allocate resources for the successful implementation of joint research projects. Both institutes also agree to organize joint seminars, workshops, and academic activities. These events will provide opportunities for students and faculty members from both institutions to collaborate, share their knowledge and experience, and build stronger relationships.

AGREEMENT FOR ACADEMIC INTERCHANGE

Between Katwa College And Purbasthali College

This Agreement is made in Katwa College between **Katwa College** and **Purbasthali College**, both affiliated to the University of Burdwan. Both parties desiring to promote and develop cooperation in research and education intend by this Agreement to establish a program of educational cooperation and student and faculty exchange.

I. The REPRESENTATIVES

Specific publicity, recruitment of students and other collaborative projects involving both institutions will be agreed between each institution's representatives. For Katwa College its representative shall be the Head of the Institution. For Purbasthali College its representatives shall be the Head of the Institution. Collaborative activities may be subject to additional terms and conditions agreed in writing between the parties' representatives.

II. STUDENT EXCHANGE PRINCIPLES IN RECIPROCITY

Exchanges shall be reciprocal and balanced over the duration of this agreement. Each institution may send up to two (2) full-year students or four (4) one-semester students per year, as the number shall be calculated in terms of "student semesters / terms" (e.g., one student for one academic year equals two student semesters / terms). However, this number may vary in any given year, provided a balance of exchanges is obtained over the term of the Agreement. The normal exchange period shall be one semester or one academic year. In the event of an anticipated imbalance, either party may suspend or reduce intake or outflow of students to maintain the balance. Exchange students will be accorded the rights and privileges of regular attendance at the host institution, excluding the rights to graduate and /or earn degrees at the host institution.

III. APPLICATION AND ADMISSION

Students who wish to participate in the exchange shall submit applications to the Principal (or other designated official) of their home institution. Exchange students shall be nominated on the basis of criteria determined by the home institution. However, all students must have completed at least two semesters of study at the home institution before beginning the exchange period and have demonstrated superior academic achievement and meet a language proficiency requirement, defined as the capability for students to succeed academically at the host institution. The host institution reserves the right to review these students and to make the final decision concerning their admission. The applications, together with other required documents, will be sent to the host institution by its designated deadline. The head of the host institution retains the right to review these students and to make the final decision concerning their admission. Lack of availability of desired classes may result in denial of otherwise qualified applicants.

IV. FEES AND SCHOLARSHIPS

Exchange students shall pay tuition fees to their home institution while tuition fees will be waived at the host institution. Neither institution shall charge exchange students for tuition or application fees. Exchange students may apply for available scholarships at the host institution. The host institution may collect certain mandatory fees from incoming students which are not required from outgoing students. All such fees will be specified in advance.

V. REGISTRATION AND RECORDS

All exchange students must register on a full-time basis. Records will be established for exchange students as if they were regular Semesters students of the host institution. An official transcript of course work and grades will be mailed to the head of the home institution on the completion of each semester of attendance.







Clause 1

CO-OPERATION

1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations.
