Sub : Fixation of pay of whole-time Non-Teaching Employees of your College in the Revised Scale(s) of Pay, 2006 as per provision vide Rule 12 of G.O. No.277-Edn.(CS), dated 21st April, 2009, under ROPA, 2009 published by the Finance Department, Government of West Bengal.

Ref : Your College Letter No. 16/P.C./1-8, dated 30.06.2010.

Sir,

With reference to your College letter on the subject mentioned above, I have to enclose a Statement showing the Fixation of Pay of 1 (one) Part-time & 7(seven) whole-time Non-Teaching Employee(s) of your College in the appropriate Revised Scale (2006) of pay in accordance with G.O. No.277-Edn.(CS) dated 21st April, 2009, subject to the terms and conditions as laid down therein.

The date of increment of a Non-Teaching Employee in the Revised Pay Scale will be deferred by the period of which he/she is granted leave without pay in any year.

The benefits of the Revised Pay Scale will be admissible to the whole-time Non-Teaching Employee concerned, upto the age of 60 (Sixty) years, the age of retirement beyond which the Revised Scale benefit will not be admissible to them.


The next increment in the Revised Scale of pay under revised pay structure of an employee whose pay is being fixed in the revised scale of pay under the said order will be granted after completion of six months and above as on 1st July. In respect of all Non-Teaching Employees there shall be a uniform date of annual increment and such date of annual increment shall be the 1st day of July of every year in the revised pay structure. The rate of annual increment shall be 3% (three percent) of the Revised Basic Pay (i.e. Revised Pay + Grade Pay) in the appropriate revised pay structure from the date of fixation of initial pay in the revised scale of pay.

If it is eventually found in any case that pay fixation has been wrongly made for any reason, such cases, if any, should forthwith be brought to the notice of this Directorate for necessary correction and the payment; if any, wrongly made on this account in excess of the admissible amount should be recovered forthwith from the next bill claims of the employee(s) concerned.

Approval of appointment may be deemed to have been given in the case of pay fixation made by this Directorate.
