About the College:



Course Objective:

The purpose of the course is to acquaint the students with the Basic Postulates of the Constitution like the Constitutional Supremacy, Rule of law, and Concept of Liberty. Give them a picture of Constitutional Parameters regarding the organization, Powers and Functions of the various Organs of the Government. The emphasis is also on the study of the nature of federal structure and its functioning. A critical analysis of the significant judicial decisions is offered to highlight judicial restraint, judicial passivity, judicial activism and judicial balancing. Finally, the students should be able to articulate their independent views over contemporary crucial constitutional issues.

DURATION: This course is designed for 30 hours. It will be rounded off within 3 months. Course will run alongside the regular courses as per routine.

ELIGIBILITY

Candidates who have successfully completed the Higher Secondary Examination (10+2) and are currently enrolled in any Undergraduate course in any affiliated college under any university in any stream are eligible to apply for the course. The student should have a basic understanding of the English language and should possess basic listening, and reading ability in English. Participants must attend at least 75% of classes without which her/his participation may be terminated at any point in time.

INTAKE CAPACITY: Maximum Thirty (30) students can be accommodated at a time. Students who meet the admission requirements and submit their applications first will be given priority over those who apply later.

AVAILABLE INFRASTRUCTURAL FACILITIES: College has sufficient number of classrooms. Dedicated smart classrooms with all modern teaching tools are also available.

MODE OF EVALUATION: At the end of this course examination of 20 (twenty) marks [$10 \times 2=20$].

Pass Marks: 10 (Ten)

<u>PATTERN OF EVALUATION</u>: Among (Ten) questions students are required to attempt ten short type questions containing two marks each.
